## Application:

Please note that the application gives no legal claim to an exhibition stand for SMM – only for 5 February 2021 at the Maritime Career Market area. Hamburg Messe und Congress GmbH assigns your stand location. Stands will be allocated on the basis of “First come – first serve”. Limited number of stand places is available.

## Withdrawal:

(Please note Art. 8.1 of the General Terms of Participation)

If the exhibitor withdraws his application before admission, HMC is entitled to charge a fee of 100.– € plus VAT. After acceptance (receipt of admission documents), rescission by the exhibitor is no longer possible. Non-participation by the exhibitor does not release the exhibitor from his contractual duties. In particular, he is still obliged to pay the contractually due charges.

## Exchange of exhibitor:

The transfer of the booked stand space is only possible by prior approval of HMC and signing a transfer agreement.

## Exhibit protection:

Subject to a decision by the Federal Justice Ministry, HMC offers exhibitors a certificate for submission to the German Patent and Trade Mark Office that the exhibit to be protected (consumer/investment product, design/utility model) has been exhibited at SMM. For further information see approvals and applications.

## Acoustic performances:

(General Terms of Participation no.13)

During regular opening hours, music performances or music played as well as presentations on exhibition grounds may not exceed a sound level of 60 decibels. Copyrighted acoustic performances have to be announced.

## Rates for participation:

The participation fee includes the hiring as well as the construction of the info stand.
